

# GLOSSARY FOR STUDENT CONDUCT STATISTICS

Updated October 2025

- **“% of Students Responsible”** represents the percentage of total students seen found responsible for alleged Student Conduct Code violations.
- **“%SC” and “%TOT”** refers to the percentage of students within the entire student conduct process a given statistical measure. For example, an “% SC” of 40.4 for students identifying as female means that 40.4 percent of all students in the student conduct process for the year identified as female.
- **“Case”** refers to the overall incident (i.e. Incident Report #00757-2020) and serves as the umbrella for all students involved with the incident.
- **“Community Contacts”** refers to informational reports submitted by Resident Assistants regarding interpersonal difficulties that disrupt, or have the potential to disrupt, a student’s living environment and/or academic success. These reports do not document policy violations.
- **“Ext/Oth”** refers to students enrolled in UCSD Extension or other program (e.g. exchange program).
- **“GR/PS”** refers to graduate and professional school students. This includes the Graduate Division, the School of Global Policy and Strategy, Rady School of Management, School of Medicine, and Skaggs School of Pharmacy.
- **“Notice of Informal Warning”** refers to the letter sent to students warning about specific alleged violations not rising to the level of a resolution meeting with a Student Conduct Officer.
- **“Resolutions”** refer to the number of individual meetings with students to resolve alleged Student Conduct Code violations. This number includes resolutions where the student failed to appear for a meeting with the Student Conduct Officer.
- **“SC % UCSD”** refers to the number of students within the student conduct process as a percentage of the entire UC San Diego population for a given statistical measure. For example, an “SC % UCSD” of 7.2 for first year students means that 7.2 percent of all UC San Diego first year students were involved in student conduct incidents during the year.
- **“Students Responsible”** refers to the number of students who accepted responsibility for alleged violations of the Student Conduct Code in an Administrative Resolution Meeting or were found responsible for at least one alleged violation in a Student Conduct Review or Formal Hearing. This also includes students who did not attend Administrative Resolution Meetings and were found responsible for alleged violations by Student Conduct Officers.
- **“Students Not Responsible”** refers to the number of students whose cases were dismissed by Student Conduct Officers because the applicable evidentiary standard was not met. This also includes students found not responsible for all alleged violations in a Student Conduct Review.
- **“Total Individuals”** refers to unique students processed through the student conduct process for alleged violations. A student may only be counted one time for this number.
- **“Total Students”** refers to the total number of students processed through the student conduct process for alleged violations. A student is counted for each incident they are involved with during the academic year.

- **“UCSD%”** refers to the percentage of students for the entire UC San Diego population in a given statistical measure. For example, an “UCSD%” of 17.5 for first year students means that 17.5 percent of all UC San Diego students are classified as first year students.
- **“UG%”** refers to the percentage of undergraduate students for the entire UC San Diego population in a given statistical measure. For example, an “UG%” of 10.5 for “Not Given or Decline to State” ethnicity means that 10.5 percent of all undergraduates identified with that ethnicity during the year.
- **“Violation”** refers to the Student Conduct Code allegations to be resolved through the student conduct process.
