<b>5. CONTROLLED SUBSTANCES</b>	<ul style="list-style-type: none"> <li>▪ See Alcohol and Controlled Substances Sanctioning Guidelines</li> </ul>	
<b>6. FAILURE TO COMPLY</b>	<ul style="list-style-type: none"> <li>▪ Probation (minimum one quarter)</li> <li>▪ Practical Decision Making Assessment and Reflection</li> <li>▪ <b>NOTE</b> – This often accompanies other violations and will increase the normal sanctions.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Community Service</li> <li>▪ Creative/other sanctions</li> <li>▪ Formal Warning</li> <li>▪ Letter of Apology</li> <li>▪ Meetings with staff members</li> </ul>

FIRE POLICY</b></p>	<ul style="list-style-type: none"> <li>▪ Fire Policy violations, except as listed below               <ul style="list-style-type: none"> <li>○ Notice of Informal Warning (first violation) or Formal Warning</li> <li>○ Removal of items (if applicable)</li> </ul> </li> <li>▪ Fire doors, flammable/corrosive substances               <ul style="list-style-type: none"> <li>○ Probation (minimum 1 quarter)</li> <li>○ Practical Decision Making Assessment &amp; Reflection</li> </ul> </li> <li>▪ False fire alarms, fire and emergency equipment, explosive substances               <ul style="list-style-type: none"> <li>○ Suspension (minimum 1 quarter) – tampering with devices</li> <li>○ Probation for tenure while living in on-campus housing</li> <li>○ Practical Decision Making Assessment and Reflection</li> </ul> </li> </ul>	<ul style="list-style-type: none"> <li>▪ Community Service (min. 10 hrs.)</li> <li>▪ Creative/other sanctions</li> <li>▪ Meetings with staff members</li> <li>▪ Restitution (if applicable)</li> <li>▪ Suspension or dismissal from University (egregious cases for all violations)</li> </ul>

GUESTS AND ADDITIONAL OCCUPANTS</b></p>	<ul style="list-style-type: none"> <li>▪ Formal Warning</li> <li>▪ Reflection/Research Paper</li> </ul>	<ul style="list-style-type: none"> <li>▪ Guest restriction</li> <li>▪ Practical Decision Making Assessment and Reflection</li> <li>▪ Probation (min. 1 quarter)</li> <li>▪ Referral of guest to “home institution” student conduct process (if applicable)</li> </ul>

HEALTH AND SAFETY</b></p>	<ul style="list-style-type: none"> <li>▪ Probation (minimum 1 year)</li> <li>▪ Practical Decision Making Assessment and Reflection</li> </ul>	<ul style="list-style-type: none"> <li>▪ Community Service</li> <li>▪ Creative/other sanctions</li> <li>▪ Exclusion from areas or activities</li> <li>▪ Follow-up meetings</li> <li>▪ Suspension or Dismissal from the University (egregious violations)</li> </ul>

<b>10. LIVING SPACE AGREEMENT</b>	<ul style="list-style-type: none"> <li>▪ Referral for alternative resolution (Community Contact, Restorative Justice)</li> <li>▪ Sanctions for repeat or severe violations of the terms of the agreement depend on the specific terms violated, the number of times the agreement has been violated, and the student's conduct record.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Creative/other sanctions</li> <li>▪ Formal Warning</li> <li>▪ Meetings with staff members</li> <li>▪ Notice of Informal Warning</li> <li>▪ Practical Decision Making Assessment and Reflection</li> <li>▪ Probation (min. one qtr.; egregious/repeated violations)</li> <li>▪ Review of Living Space Agreement</li> </ul>
<b>11. <b>13. RESIDENTIAL RESTAURANT AND MARKET SERVICES</b>	<ul style="list-style-type: none"> <li>▪ Dishware and Dress Code violations <ul style="list-style-type: none"> <li>○ Formal Warning</li> </ul> </li> <li>▪ Recreational Activities, Food Fights, Health and Safety, and Meal Plan Use violations <ul style="list-style-type: none"> <li>○ Probation (minimum 1 year)</li> <li>○ Practical Decision Making Assessment &amp; Reflection</li> <li>○ Restitution (if applicable)</li> </ul> </li> <li>▪ Theft violations <ul style="list-style-type: none"> <li>○ See Other Violations Sanction Guidelines (PACAOS 102.04)</li> </ul> </li> </ul>	<ul style="list-style-type: none"> <li>▪ Community Service</li> <li>▪ Creative/other sanctions</li> <li>▪ Exclusion from areas or activities</li> <li>▪ Meetings with staff members</li> <li>▪ Notice of Informal Warning</li> <li>▪ Practical Decision Making Assessment and Reflection</li> <li>▪ Suspension or dismissal from the University (for egregious or repeated violations)</li> </ul>

<b>17. SMOKE AND TOBACCO FREE ENVIRONMENT</b>	<ul style="list-style-type: none"> <li>▪ Notice of Informal Warning (first violation) OR Formal Warning (second violation)</li> <li>▪ See Alcohol and Controlled Substances Sanctioning Guidelines for violations connected to cannabis and other controlled substances.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Community Service (min. 5 hrs.)</li> <li>▪ Creative/other sanctions</li> <li>▪ Formal Warning</li> <li>▪ Reflection/Research Paper</li> <li>▪ Smoking cessation meeting</li> </ul>

WEAPONS/ EXPLOSIVES</b></p>	<ul style="list-style-type: none"> <li>▪ Improper chemical discharge               <ul style="list-style-type: none"> <li>○ Probation (minimum 1 year)</li> <li>○ Practical Decision Making Assessment and Reflection</li> </ul> </li> <li>▪ Firearms, ammunition, weapons, or items/implements               <ul style="list-style-type: none"> <li>○ Suspension (minimum 1 year)</li> <li>○ Probation (minimum tenure)</li> <li>○ Practical Decision Making Assessment and Reflection</li> <li>○ Exclusion from areas or activities</li> </ul> </li> <li>▪ <b>NOTE</b> – Students involved with Recreation martial arts programs generally can keep their equipment in living spaces so long as they they’ve notified their Residential Life or Housing Office and do not use the equipment.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Community Service (25 to 50 hrs.)</li> <li>▪ Creative/other sanctions</li> <li>▪ Dismissal (egregious violations - all types)</li> <li>▪ Meetings with staff members</li> <li>▪ Probation (min. 1 qtr.; if mitigating factors present for firearms, ammunition, weapons, items/implements violations)</li> <li>▪ Suspension (egregious chemical discharge violations)</li> </ul>
